2. PRODUCT COMPOSITION

Aerosol comprising of Butane, Methyl Nicotinate, Methyl Salicylate, Ethyl Salicylate, 2 – Hydroxyethyl Salicylate and Propan-2-ol.

3. HAZARD IDENTIFICATION

For external use only. Avoid contact with the eyes and inhalation. Protect the face when spraying around the neck and shoulders. Always use sparingly since some people may experience discomfort, particularly those with sensitive skin. Avoid spraying onto broken skin. Not to be used on children under 5 years. If symptoms persist or if any unwanted effects are seen consult your doctor. Keep all medicines out of the reach of children.

Warning: Pressurised container – protect from sunlight and do not expose to temperatures exceeding 50°C. Do not pierce or burn, even after use. Do not spray on a naked flame or any incandescent material. Keep away from sources of ignition – no smoking.

4. FIRST AID MEASURES

Eyes: Immediately wash out the eye with copious amounts of water for at least 10 minutes. If discomfort persists seek medical attention.

Skin: Wash thoroughly with soap and water. If irritation occurs seek medical attention.

Inhalation: Remove from exposure.

Ingestion: Wash out mouth thoroughly with water. In severe cases seek medical attention.

5. FIRE-FIGHTING MEASURES

Extinguishing Media: Use foam, dry powder, carbon dioxide. Avoid using large quantities of water.

Precautions: Self-contained breathing apparatus should be worn.

6. ACCIDENTAL RELEASE MEASURES

For bulk quantities only, wear appropriate protective clothing. Contain and collect spillage using a suitable inert absorbent. Shovel to waste and dispose of according to local authority regulations.

7. HANDLING AND STORAGE

Always wash hands thoroughly after use and before eating. Store under ambient conditions. Always reseal container after use.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Protect the face when spraying around the neck and shoulders. If bulk product is used for any reason additional precautions such as safety goggles and gloves should be used.

9. PHYSICAL AND CHEMICAL PROPERTIES

Methyl Nicotinate: 1.6 % w/w
Methyl salicylate: 1.0 % w/w
Ethyl salicylate: 5.0 % w/w
Hydroxyethyl salicylate: 5.0 % w/w

10. STABILITY AND REACTIVITY

This product is considered to be stable under ambient conditions. Avoid extreme temperatures.

11. TOXICOLOGY INFORMATION

Quantitative data on the toxicity of this product is not available.

Skin contact: May cause irritation on broken skin

Inhalation: Remove from exposure to fresh air. If problems persist seek medical attention.
